Introdução à Fisiologia Humana

Principais Componentes Celulares

1. **Membrana plasmática:** controla o transporte de materiais e transmite sinais.
2. **Núcleo:** contém o material genético e regula as atividades

celulares.

3. **Mitocôndrias:** responsáveis pela produção de energia através da respiração celular.
4. **Retículo endoplasmático e complexo de Golgi:** envolvidos na síntese e processamento de proteínas.
5. **Citoplasma:** matriz onde ocorrem diversas reações químicas.

Homeostase e Controle Neural e Endócrino

A manutenção do ambiente interno do corpo é fundamental para a sobrevivência. Berne e Levy destacam que essa estabilidade resulta da interação entre sistemas nervoso e hormonal.

Sistema Nervoso

O sistema nervoso atua como um sistema de controle rápido, capaz de responder a estímulos de forma instantânea. Ele é dividido em sistema nervoso central (cérebro e medula espinhal) e sistema nervoso periférico (nervos e gânglios).

Sistema Endócrino

Por sua vez, o sistema endócrino regula funções de forma mais lenta, utilizando hormônios que são liberados na corrente sanguínea. Esses hormônios atuam em órgãos-alvo específicos, ajustando processos fisiológicos como crescimento, metabolismo e reprodução.

Fisiologia do Sistema Circulatório

O sistema circulatório é responsável por transportar sangue, nutrientes, gases, hormônios e resíduos pelo corpo. Segundo Berne e Levy, ele é composto pelo coração, vasos sanguíneos e sangue propriamente dito.

O Coração

O coração funciona como uma bomba que impulsiona o sangue através do sistema vascular. Sua estrutura inclui quatro câmaras: dois átrios e dois ventrículos.

Vasos Sanguíneos

1. **Artérias:** transportam sangue do coração para os tecidos.
2. **Veias:** retornam o sangue dos tecidos ao coração.
3. **Capilares:** locais de troca de gases e nutrientes com os tecidos.

Fisiologia do Ciclo Cardíaco

O ciclo cardíaco envolve fases de contração (sístole) e relaxamento (diástole), reguladas por impulsos elétricos originados no nó sinoatrial, o marcapasso natural do coração.

Fisiologia Respiratória

O sistema respiratório garante a troca de gases entre o organismo e o ambiente. Segundo Berne e Levy, esse processo

envolve a ventilação pulmonar, difusão de gases e transporte de oxigênio e dióxido de carbono pelo sangue.

Processo de Ventilação

A inspiração e expiração ocorrem devido às variações de pressão nos pulmões, controladas pelos músculos respiratórios, principalmente o diafragma.

Troca Gasosa nos Pulmões

Nos alvéolos, o oxigênio difunde-se para o sangue, enquanto o dióxido de carbono difunde-se do sangue para os pulmões para ser eliminado.

Transporte de Gases

O oxigênio é transportado principalmente pela hemoglobina, enquanto o dióxido de carbono é transportado como bicarbonato, ligado à hemoglobina ou dissolvido no plasma.

Fisiologia do Sistema Nervoso

O sistema nervoso coordena atividades do corpo, integrando informações sensoriais e gerando respostas motoras. Segundo Berne e Levy, ele é dividido em sistema nervoso somático, autônomo e central.

Sistema Nervoso Central (SNC)

Inclui cérebro e medula espinhal, responsáveis pelo

processamento de informações e tomada de decisão.

Sistema Nervoso Periférico (SNP)

Composto por nervos e gânglios, conecta o SNC aos músculos, glândulas e órgãos sensoriais.

Neurônios e Sinapses

Os neurônios transmitem impulsos elétricos através de sinapses, que podem ser químicas ou elétricas, facilitando a comunicação rápida entre células.

Fisiologia do Sistema Endócrino

O sistema endócrino regula diversas funções do corpo através da liberação de hormônios. As principais glândulas incluem hipófise, tireoide, suprarrenais, pâncreas e gônadas.

Hormônios e Mecanismos de Ação

Os hormônios podem atuar de duas formas:

1. **Receptores na membrana celular:** para hormônios peptídicos.
2. **Receptores intracelulares:** para hormônios esteroides.

Regulação Hormonal

A liberação hormonal é controlada por mecanismos de retroalimentação, que ajustam a produção de hormônios com

base na necessidade do organismo.
