2. **Venen:** Führen sauerstoffarmes Blut zurück zum Herzen.
3. **Kapillaren:** Feinste Gefäße, die Austauschprozesse zwischen Blut und Gewebe ermöglichen.
4. **Lymphgefäße:** Transportieren die Lymphe, eine klare Flüssigkeit, die Abfallstoffe und überschüssige Flüssigkeit aus dem Gewebe ableitet.

Das Gefäßsystem ist hochkomplex und weist zahlreiche anatomische Variationen auf, die bei Diagnostik und Therapie berücksichtigt werden müssen.

Physiologie der Gefäßsysteme

Blutfluss und Kreislauf

Der Blutkreislauf besteht aus:

1. Der großen Kreislauf (Systemkreislauf), der den Körper versorgt.
2. Der kleinen Kreislauf (Lungenkreislauf), der den Gasaustausch in der Lunge ermöglicht.

Der Blutfluss wird durch das Herz angetrieben und durch Widerstände in den Gefäßen reguliert. Faktoren wie Gefäßdurchmesser, Blutviskosität und Gewebeanforderungen beeinflussen die Durchblutung.

Lymphsystem

1. Lymphgefäßen
2. Lymphknoten
3. Lymphorganen (z.B. Milz, Thymus)

Die Funktion des Lymphsystems ist essenziell für die Aufrechterhaltung der Gewebeflüssigkeit und die Abwehr

von Infektionen.

Diagnostische Verfahren in der Angiologie

Bildgebende Verfahren

Die Diagnostik vaskulärer Erkrankungen erfolgt durch verschiedene bildgebende Techniken:

2. Kapillarmikroskopie
3. Venöse Funktionstests (z.B. Trendelenburg-Test)

Häufige Krankheitsbilder in der Angiologie

Arterielle Erkrankungen

Die häufigste arterielle Erkrankung ist die periphere arterielle Verschlusskrankheit (pAVK), bei der Durchblutungsstörungen an den Extremitäten vorliegen.

Klassifikation der pAVK nach Fontaine:

1. Stadium I: Asymptomatisch
2. Stadium II: Claudicatio intermittens (Schaufensterkrankheit)

Lymphatische Erkrankungen

6. Cholesterinsenkung

Früherkennung und regelmäßige Vorsorgeuntersuchungen sind entscheidend, um Komplikationen zu vermeiden und die Lebensqualität zu erhalten.

Zentrale Krankheitsbilder in der Angiologie

Arterielle Erkrankungen

Die arteriellen Erkrankungen sind durch Verengungen oder Verschlüsse der Arterien gekennzeichnet, die die

Durchblutung einschränken oder vollständig blockieren. 1.

Arteriosklerose (Arterielle Verkalkung): Die häufigste Ursache für vaskuläre Erkrankungen. Es handelt sich um eine chronisch-entzündliche Erkrankung, bei der sich

Akute arterielle Verschlüsse: Ursächlich meist Thrombosen oder Embolien, die sofortige medizinische Intervention erfordern.

Venöse Erkrankungen

Venöse Erkrankungen betreffen vor allem die Venen und sind häufig durch chronische Stauungen oder Thrombosen gekennzeichnet. 1. Chronisch-venöse Insuffizienz: Schwäche der Venenklappen, führt zu Rückstau, Varizen (Krampfadern), Ödemen und Hautveränderungen. 2. Laboruntersuchungen

- Blutbild: Hinweise auf Entzündungen oder Anämie. - Lipidprofil: Cholesterin- und Triglyzeridwerte zur Risikoabschätzung. - Gerinnungsstatus: Wichtig bei Thrombosen und bei Planung von Eingriffen. - Entzündungswerte: CRP, BSR.

- Laufband-Test: Beurteilung der Belastungsfähigkeit bei pAVK. - Venöse Funktionstests: Tourniquet-Test, Valsalva-Manöver. - Lymphoscintigraphie: Funktionelle Untersuchung des Lymphsystems.

Operative Eingriffe

- Bypass-Operationen: Umgehung verstopfter Gefäße, z.B. Koronar- oder Beckenarterien. - Aneurysma-Resektion: Entfernung und Rekonstruktion geschwächter Gefäße. - Lymphknotenentfernung oder -rekonstruktion: Bei

Tumoroperationen oder Lymphödem.
