

RUMUS PENILAIAN OBLIGASI

Rumus Penilaian Obligasi

1. Nilai Obligasi = **Present Value (PV) dari semua pembayaran bunga + Present Value (PV) dari nilai pokok (nilai nominal)**

Rumus Rinci Penilaian Obligasi

Contoh Perhitungan Penilaian Obligasi

Sebagai contoh, misalkan ada obligasi dengan ketentuan berikut: - Nilai nominal (F) = Rp 1.000.000 - Tingkat kupon tahunan = 10% dari nilai nominal (Rp 100.000 per tahun) - Jangka waktu sampai jatuh tempo = 5 tahun - Tingkat diskonto pasar = 8% per tahun Langkah-langkah perhitungannya adalah:

1. Hitung pembayaran kupon tahunan

$$C = 10\% \times \text{Rp } 1.000.000 = \text{Rp } 100.000$$

2. Hitung PV dari pembayaran kupon

$$\begin{aligned} PV_{\text{kupon}} &= \text{Rp } 100.000 \times \left(\frac{1 - (1 + 0,08)^{-5}}{0,08} \right) \\ PV_{\text{kupon}} &= \text{Rp } 100.000 \times \left(\frac{1 - (1 + 0,08)^{-5}}{0,08} \right) \\ PV_{\text{kupon}} &\approx \text{Rp } 100.000 \times 3,993 \\ PV_{\text{kupon}} &\approx \text{Rp } 399.300 \end{aligned}$$

3. Hitung PV dari nilai pokok

$$\begin{aligned} PV_{\text{nilai pokok}} &= \text{Rp } 1.000.000 \times (1 + 0,08)^{-5} \\ PV_{\text{nilai pokok}} &\approx \text{Rp } 1.000.000 \times 0,6806 \\ PV_{\text{nilai pokok}} &\approx \text{Rp } 680.600 \end{aligned}$$

4. Hitung nilai pasar obligasi

$\text{Harga obligasi} = \text{Rp } 399.300 + \text{Rp } 680.600 = \text{Rp } 1.079.900$ Jadi, nilai wajar obligasi tersebut adalah sekitar Rp 1.079.900, yang menunjukkan bahwa obligasi ini dihargai di atas nilai nominalnya, kemungkinan karena tingkat kupon yang lebih tinggi dari tingkat diskonto pasar.

Faktor-Faktor yang Mempengaruhi Penilaian Obligasi

Dimana: - F = nilai nominal - r = tingkat diskonto per periode - n = jumlah periode sampai jatuh tempo Contoh, jika obligasi zero-coupon dengan nilai nominal Rp1.000.000 dan jatuh tempo 3 tahun, dengan tingkat diskonto 9%, maka: $\text{Nilai} = \text{Rp}1.000.000 / (1 + 0,09)^3 \approx \text{Rp}772.183$ Obligasi ini biasanya dijual dengan diskon dari nilai nominal dan akan mendapatkan laba dari selisih saat jatuh tempo.

Pengaruh Tingkat Diskonto terhadap Penilaian Obligasi
